Epilepsy Warning

Installation and Start

Further Requirements and Help

The installation requires a one-time internet connection for the authentication as well as the Steam client (included with the game).

Windows PC Installation

Please ensure that your computer is connected to the internet before starting the Oil Enterprise installation process. Insert the Oil Enterprise disc into your computer's disc drive. During the installation process, a one-time online check will be carried out to verify the disc. An activation file will then download, which will require a product code. You will find the code on the back of this manual.

Insert the disc into your disc drive. After a few seconds a window will appear on the screen. Follow the instructions for the installation, selecting the folder in which you would like to install the game. If the program does not start automatically, double-click My Computer on your Windows desktop. Then double-click your disc drive icon, followed by the installation file icon "setup.exe".

Starting the Game

Following successful installation, launch the program by selecting **Start/All Programs/Steam/Oil Enterprise** in the Windows Start menu or via the corresponding icon on the desktop.

If you encounter security messages when launching the autostart menu on Windows 7, Windows 8 or Windows 10, please note that it is safe to run the "setup.exe" program.

Uninstallation

Select Start/Settings/Control Panel/Software and choose the "Oil Enterprise" entry. Then click on the Add/Remove button. The program itself, as well as files and game data, will then be uninstalled.

Network game

Under "Network game" you can take on one of many scenarios with up to eight players on a local network and see how you measure up against the other players.

Start scenario

Under "Start scenario" you can start a range of predefined scenarios and put your skills to the test by fulfilling various goals and targets. If you start the "Tutorial" scenario, you will be given a comprehensive introduction to the game.

Continue/Load game

Resume your saved game by selecting "Continue" or load an old save by choosing "Load Game".

Free play

In "Free play" mode, you can define your own starting and victory conditions.

Settings

You can adjust various game, graphics and sound settings under "Settings". Credits Here you can see who was involved in making the game.

Open forum

If you need information, updates or help with the game, you can access the official developer forum under "Open forum".

World Map

WORLD MAP HEADQUARTERS OILFIELD

The world map shows you all the available oil production areas. You need a regional license to access a region. Once you have unlocked a region, you can purchase oilfields and exploit the oil reserves. The items "Construction time", "Construction costs", "Maintenance" and "Safety" vary from region to region.

Headquarters

The headquarters are your oil company's main office and your personal calling card. Here you can purchase various buildings to increase, for example, your company's pump production volume or its capacity limits.

Oilfield

Here you will find a brief overview of all your oilfields along with their daily production volumes. The arrow will take you to the respective oilfield.

Lightbulb



If ever you don't know what to do, click the lightbulb icon for useful information, or alternatively press F1 on your keyboard.





The map in the bottom left corner of the screen shows the current area and game date, and provides you with information on the daily oil output and your current oil reserves. Clicking on Pause will pause the game. Click on Play to resume the game at normal speed and on Fast forward to increase the speed of the game. The Account balance shows you how much money you currently have.

Production Overview



The Production Overview provides information on your capacity and utilization of pumps, refineries, storage and logistics.





Expand your oilfield by building additional pumps, refineries and storage.

Free Market



On the free market you will see the market price of oil per barrel over the last twelve months and can sell your stocks.

Available Contracts



Beside the free market, you can also generate revenue by signing contracts. Note the different conditions here and that you will have to pay contractual penalties if you are unable to deliver the contractually agreed quantities of oil on time.

Oilfield Info



Here you will find all the interesting facts about the current oilfield, such as its size, deposit size and the current yield.

Maintenance and Safety



Servicing and maintaining your buildings is important to guarantee oil production and not least the safety of your oilfields.

Cost Analysis



Here you will see a cost analysis for your company per year.

Scenario Goals



Here you can find out the goals that need to be fulfilled to complete the scenario. When in free play you will only be subject to the goals you have set yourself.

Repair/Demolish Buildings

If you need to repair a building, left-click it and then carry out a repair. Note that a repair costs time and money and you yourself will need to know when a repair is worthwhile. If a building is in the way or repairing it is too expensive, you can completely demolish it and redevelop the reclaimed land.
